**MOVE-UPS AT THE TRIAL:** Move-ups from Sat to Sun for duplicated classes will be taken until the end of the last class on Sat. No exceptions.

**MEASURING:** There will be no measuring of dogs after the judge's briefing begins each day. All dogs without a Permanent Card (P-Card) must be measured before the judge's briefing to show that day. **There will be no exceptions.**

**PRIZES & AWARDS:** Placement rosettes or ribbons will be awarded for 1<sup>st</sup> through 4<sup>th</sup> place for Qualifying and non-qualifying scores for all classes. Dogs with an NT (no time) are not eligible for any ribbons. Qualifying ribbons will be awarded to all dogs receiving a qualifying score, and Jr Handlers in Standard.

EXERCISE YOUR DOG RESPONSIBLY! PLEASE PICK UP AFTER YOUR DOG AT THE SHOW SITE AND HOTELS! ALL DOGS MUST BE ON LEASH EXCEPT WHEN IN THE RING OR WARM UP AREA. THERE IS A LEASH LAW IN OREGON.

**OBSTACLES:** The following obstacles may be used. Obstacle specifications shall meet the current CPE obstacle requirements.

### NOTICE TO EXHIBITORS

- The safety of the dogs is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all obstacles safely.
- Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the show committee.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dog(s) and / or children. Any exhibitor whose dog(s) and / or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the show committee, be asked to leave the show site. In that case, no refund of any fees paid will be made.
- No entry fee will be refunded if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee.
- Exhibitors are responsible for complete, accurate, and legible information on the entry forms: illegible or incomplete entries cannot be entered in the show.

#### Additionally:

- Confirmation letters will be sent by email except if there is no email address listed on the entry form or the exhibitor specifically requests to receive his/her confirmation letter by postal mail.
- 100% of entry fees will be refunded if requested before or on the closing date of May 10, 2023. Refunds for withdrawals requested after the closing date but before the first competition date listed in this premium will be made only for injured or ill handlers or injured, ill or in-season dogs. Owner/handler will receive a refund less a \$20 per dog handling fee. Verification from a doctor or vet may be requested.
- There shall be no refunds for withdrawals requested on or after the first competition date listed in this premium, regardless of the reason.
- Checks will be held until the closing date. There will be a \$20 service charge for returned checks. Payment in full of entry fees and service charges shall be made by money order or cash before the first date of competition listed in this premium.
- Exhibitors are advised that this is private property. **Please do not allow dogs to the north of the trees lining the driveway.** To ensure the continued availability of this site, exhibitors must conduct themselves in a responsible and respectful manner. Exhibitors are responsible for the appropriate conduct of their guests, children and dogs.
- Dogs must be exercised only in designated areas.

### PLEASE CLEAN UP AFTER YOUR DOG

#### DIRECTIONS TO SHOW SITE: Larry Paulus Hay Barn • Hwy 99 Monmouth, Oregon

**From I-5 (north or south):** Take Hwy 22 West (from Salem) approx. 10 miles to Hwy 99W (Pacific Hwy). Head south (toward Rickreall and Monmouth) on Hwy 99W and go approx. 6 miles to Monmouth. Continue south at the signal at Hwy 99W and Main St. in Monmouth for 2.6 miles. The arena is on the left (east) across from the white fencing.

**Coming from the south on 99W:** The driveway is just past milepost #66.

**GPS:** 44.81023, -123.22475     **Plus code:** RQ6G+33 Monmouth, Oregon

**To help you find the arena:** Just south of the driveway, there are "Adopt-A-Highway" signs on both sides of the road.

**Jump Heights** – no dog will jump lower than 4”

P-Card = Permanent Card: the lowest allowable Regular height a dog may jump in CPE.

General CPE rules for entries/show site:

- Dogs must be at least 15 months or older the first day of the trial
- Blind (both eyes), lame, in season or aggressive dogs may not enter the show. The Club may choose to exclude any of the above from the site.
- Dogs must be registered with CPE prior to the closing date of the trial, or by the trial date for Day Of Show entries. Registration forms are on the Forms page: [www.k9cpe.com](http://www.k9cpe.com). Forms MUST be mailed to CPE and are processed 2-3 times per week. CPE ID numbers are emailed to legible email addresses. Registrations can only be processed from mailed forms.
- Dogs must be able to be measured at their first show. If a dog cannot be measured, the dog cannot run and no refund will be issued. Dogs within ½” of a jump height require at least one more measurement. When dogs reach their second birthday, a measurement is required. All dogs must be measured at their first trial regardless of jump height.
- Only CPE Judges can measure dogs.
- Electronic shock collars are not allowed at ANY CPE trial – training or bark.
- Handlers in all classes are permitted to walk the course, without a dog, prior to the start of the class. A warm-up jump shall be provided for all entered dogs. No relieving of dogs in the warm-up area.

#### **Dogs in the ring, leashes, exiting the ring**

- Dogs can now run with or without a collar. Collars should preferably be quick release style, a flat buckle, rolled leather, or flea prevention. No attachment of any kind are allowed on the collar.
- Leashes may not have anything (other than name/license tags) attached to them when used in the ring.
- Dogs may enter the ring on a collar, quick release harness or head halti/leader. If prong collars are allowed per the show site, they may *not* be used to take a dog into the ring.
- Handlers may carry their leash with them on the course – if done so, leash must be out of sight or clipped around shoulders or hips.
- Dogs must be under the handler’s control when leaving the ring or the judge may enter the run as No Time - NT.

#### **For clubs that will allow Declared Training In the Ring**

We (Host Club) will offer Declared training in the ring. The handler has the option if they want to use a toy or training aid at any time during their run, the handler must approach the Judge during Walkthrough or previously in that trial day for the Judge to approve the toy or training aid for use on the course.

- Handler must alert the Judge upon entry to the ring that the dog will be TIR. Handler is then allowed to have a reasonably sized silent toy/aid with them for use once their run has started (this toy must be approved by the Judge of record PRIOR to the start of the class to determine its eligibility, absolutely no food/scents/audible devices). The toy is NOT allowed to be used in either gate chute or prior to the previous dog leaving the ring. See the online rulebook or current member letter for additional rules. The following items are considered training in the ring (see Fix and Go):
- Violating the 4 paw safety rule (directing the dog back onto the contact)
- Start line stay – leaving the dog and going back again to reposition the dog after the handler passes the plane of the first obstacle (before the handler leaves the dog, repositioning or repeated commands can be a delay of start)
- Putting the dog back on the table in the point games

#### **While running on course**

- The handler will direct the dog through the course without a lead.
- Food, toys, training devices (includes fanny packs and leash attachments) are not allowed within 10’ feet of the ring. Clickers, training whistles and squeaky toys are not to be used within distraction distance of the ring.
- The handler may not carry anything that could aid the dog in its performance. Exclusion: Handicapped/Differently Abled Handlers using a cane, scooter, wheelchair, etc., to enable their progression around the course.

The handler may use any verbal or visual commands to direct the dog through the course. The Judge may assess a 5 fault penalty to elimination for any command that is not given in a sportsmanlike manner. Faults can be, but are not limited to: foul or abusive language, display of anger, extreme frustration or excessive harshness. If the fault is severe enough, the Judge has the right to excuse the exhibitor from the ring and / or the remainder of the trial. If excused from the trial, a report would be filed with CPE. See Faults, Eliminations and Excusals in the rulebook.
